ADR IN BACOLAW

BACOLAW is in partnership with the Nigerian Institute of Chartered Arbitrators (NICArb) for the training of young Arbitrators through the Associate membership examinations and registration. The essence of the training is to expose and introduce the students very early in their career development to the work of alternative dispute resolution (ADR). ADR is one of the courses taught at the 300 Level class in the Bachelor of Laws (LL. B) programme in the College.

The first set of eighteen students went through the training and passed the Institute's Associate Membership Examinations in 2018 and were inducted as Associate members of NICArb in December 2018. A second batch of thirty-one students successful went the training in April and passed the examination in May 2019. The thirty-one young Arbitrators are to be inducted as Associate members of NICArb in the fourth quarter of 2019.
